AN ORDINANCE TO AMEND THE 2023
REFUSE FUND BUDGET TO COVER
RETIREMENT AND FUEL EXPENSES AND
TIPPING FEES

WHEREAS, the Acting Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Refuse Fund budget to cover retirement and fuel expenses and tipping fees in the amount of \$102,960; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on December 20, 2023.


NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Refuse Fund budget to cover retirement and fuel expenses and tipping fees in the amount of \$102,960 as follows:

- (i) \$ 50,000 decrease expense budget line CL8160.51000 (Personal Svcs – St Maint)
- (ii) \$ 52,960 increase revenue budget line CL.41710 (Public Works Charges)
- (iii) \$ 4,000 increase expense budget line CL8160.54112 (Gas/Fuel)
- (iv) \$ 48,960 increase expense budget line CL9010.58000A (Retirement)
- (v) \$ 50,000 increase expense budget line CL8160.54661 (Tipping Fees)

Section 2. That this Ordinance shall take effect immediately.
