VIII. PUBLIC COMMENT

- Kenneth Brown, Westside Resident: Talks about personal opposition to previously proposed citizensponsored RL "Police Choice Act", as local oversight of Police Department is essential. Addresses local
 Republican candidate's/official's statements as misleading, stating that listening to ideas to increase
 civic engagement is not equivalent to support of an idea: "I disagree with what you say, but I defend to
 the death your right to say it." Brown further commends the Council for their commitment to
 engagement. Brown goes on to discuss the RL he submitted to eliminate cronyism, stating "any
 company with direct financial ties to the City of Binghamton should be barred from obtaining a
 contract", pointing to a former Councilmember who was able to serve while their company received
 large contracts from the City. Mentions that his wife's family is hosting a free community meal for all on
 Easter Sunday from 1-5PM with a goal of 200 meals distributed.
- Marty Doorey, Eastside Resident: Commends City Council for listening to citizen's ideas, considers previous RL ludicrous, but appreciates the difference between listening to constituents and endorsing legislation. Doorey criticizes the Mayor for trying to control the legislative branch of City government, both regarding "Police Choice Act" and the tie in the 6th district election. Commends CM Cavanaugh for being willing to consider shared service agreement.
- John Solak, Binghamton Resident: Solak states "Kraham should go to Chenango Valley and get a civics textbook". RL form has been open to the public, can be gotten from the Clerk like he did, where he received "5-star service". Solak says he believes in fair play, believes that the Council should hold a vote on his "Police Choice Act" regardless of individual feeling to have a decision made for the public.

This continues to be my reality. Binghamton City Council seeks to enhance citizen participation in government, regardless of opinions about the message or messenger. CM Cavanaugh: Cavanaugh seeking CDAC representative for 3rd District, encourages people to send applications to clerk@cityofbinghamton.gov or directly to Council email. Reiterates willingness to have open discussions in meetings, prioritizing listening and engagement. States that engagement is not equivalent to endorsement.

CM Hotchkiss: Hotchkiss mentions feeling encouraged seeing multiple pieces of constituent-sponsored legislation, eager to have a more collaborative relationship with residents.

CM Dundon: "A true leader is not a follower of consensus; a true leader is a molder of consensus." -MLK. Dundon states this past week has shown that this Council is determined to change things versus just going with the status quo and will continue to fight the good fight.
