**AN ORDINANCE TO AMEND THE 2023 WATER  
AND SEWER FUND BUDGET FOR  
RETROACTIVE PAY FOR 5 EMPLOYEES DUE  
TO GRIEVANCE DECISION ON 12/15/2023**

WHEREAS, the Water and Sewer Superintendent and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Water and Sewer Fund budget for personal services to increase funds for retroactive pay for 5 employees pursuant to a grievance decision filed by Local 317; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on February 21, 2024

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Acting City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2023 Water and Sewer Fund budget for personal services to increase funds for retroactive pay for 5 employees as follows:

\$180.40 G9030.58000C (PERS. SVC.)


