WHEREAS, the Water and Sewer Superintendent and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2023 Water and Sewer Fund budget for personal services to increase funds for retroactive pay for 5 employees pusuant to a grievance decision filed by Local 317; and
