AN ORDINANCE AMENDING THE 2024
GENERAL FUND BUDGET TO ALLOW FOR
THE DEMOLITION OF A FIRE DAMAGED
PROPERTY AT 17 WILLIAM STREET

WHEREAS, the Mayor and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2024 General Fund budget for the demolition of a fire damaged property at 17 Williams Street; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on March 13, 2024.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and the Acting City Treasurer are hereby authorized and directed to amend the 2024 General Fund budget for the demolition of a fire damaged property at 17 Williams Street as follows:
