WHEREAS, the City of Binghamton wishes to enter into an intermunicipal agreement with the Broome-Tioga Stormwater Coalition for compliance with Federal Phase II MS4 Stormwater regulation implementation in Broome and Tioga Counties; and

WHEREAS, the Broome-Tioga Stormwater Coalition implements the Small municipal stormwater sewer systems (MS4) Stormwater Management Plans required by the New York State Department of Environmental Protection's Phase I Stormwater Regulations and oversees the utilization and expenditures of funds; and

WHEREAS, the City's cost to continue participation in the Broome-Tioga Stormwater Coalition is \$4,500; and

WHEREAS, funds are available for this purpose.
