DESCRIPTION FROM AGENDA: The applicant, the City of Binghamton, would like to continue with the second phase of the Downtown DECO project located on Washington, Water, Henry, Lewis, and State Streets.

Certificate of Appropriateness

DISCUSSION POINTS & THOSE SPEAKING:

- Applicant states that they would like to complete the second phase of the DECO District remodeling of the State and Henry Street District.
- Applicant states that the next phase will include Washington Street, Lewis Street, and part of Henry Street.
- Applicant states that many of the elements that were included in phase I will be included in the second phase of the District remodeling.
- Applicant states that the lighting will be the same as State Street and the benches will be all backless due to some vandalism of the larger benches.
- Applicant states that there would be approximately 19 or 20 new light posts installed, same model as State
- Applicant states that there will be a raised mid-block crossing the same as State Street as well in front of the Forum.
- Applicant states that they are working with the construction company building the parking garage to work on the crossing of Water and Henry Street.
- Staff asks where the Gobo light will be located in the district.
- Applicant states that the Gobo light used in phase 1 would be installed at the end of the district on Henry Street across from Washington Street.
- Applicant states that the crosswalks in the district will not have the triangle pattern, but will retain the rainbow coloring.
- Staff asks how many poles will have to be utilized for the lights being strung across the street.
- Applicant replies that there will be 3 new poles.
- Applicant states that the city is acquiring a walkway between the two streets, State and Washington, to provide a gateway to both areas.
- Applicant also states that they will be removing a bench in front of The Shop and are meeting with representatives from The Forum and The Lost Dog for their input.
- Commissioner states that modern theatre lights may not normally fit into a historic district, but because of the "theatre" theme of the district, it does seem appropriate.

DISCUSSION POINTS & THOSE SPEAKING:

- Applicant states that they have meetings with the private stakeholders of the project as well as one more public meeting. There will also be a Traffic Board memo about the crossing on Water Street.
- Ex officio asks if there is any communication between the company constructing the garage and the Deco district engineers because the water street crossing seems like it would be an excellent place for a gateway.
- Applicant replies that there is not enough right-of-way property that the city owns to make a gateway and also there is a system of underground vaults for utilities that makes a gateway almost impossible.
- Staff states that although not all of the details are complete, it is about as complete a plan as can be expected at this time.

Other business

- Staff states that right now they are trying to get a 7th commissioner approved by the mayor's office.
- Staff also states that in order to make the Main Street Historic District a local district, there will have to be another public meeting the date and time of which will be set at a future date.
- Commissioner asks if the City Council has looked at it already and Ex officio responds that they have already voted it in.
