ORDINANCE

AN ORDINANCE TO AMEND PERMANENT ORDINANCE 06-46 TO RESCIND PORTION REQUIRING **PROPERTY** CONVERSION

WHEREAS, on October 2, 2006, City Council adopted Permanent Ordinance 06-46 to enter into a contract of sale between the City of Binghamton and Victor and Betty Salcedo for 154 Murray Street (2006 tax map number 02-0006-054), including a provision in Section 2 that the sale would be subject to the condition that the property be converted from a two family dwelling to a single family dwelling and the subsequent deed of this property required conversion of the property or the City could exercise the right of reverter; and

WHEREAS, the property conversion requirement was not fulfilled and the subsequent deed restriction will prevent proposed future property transfer.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That City Council hereby rescinds Section 2 of Permanent Ordinance O6-46 and removes the conversion requirement and the right of reverter.

Section 2. That this Ordinance shall take effect immediately.
