AN ORDINANCE TO AMEND THE 2024 CAPITAL BUDGET TO CLOSE SERIAL BOND ACCOUNTS NO LONGER ACTIVE

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2024 Capital Fund budget to close serial bond accounts that are no longer active; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on June 26, 2024.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2024 Capital Fund budget to close serial bond accounts that are no longer active as follows:

- (i) \$456,159.92 decrease in expense budget line H7110.525277.12220 (Rec Park Tennis Courts);
- (ii) \$1,000.00 decrease in expense budget line H5110.525321.20619 (Pedestrian Improvements);
- (iii) \$180,960.58 decrease in expense budget line H5110.525345.12523 (Glenwood-Main to Clinton)
- (iv) \$2,619,847.26 decrease in expense budget line H8340.525153.21716 (Sludge Extraction)
- (v) \$3,257,967.76 decrease in revenue budget line H.45710 (Serial Bonds)

Section 2. That this Ordinance shall take effect immediately.

I HEREBY CERTIFY that the above described funds are unencumbered and available.
