A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT THE U.S. DEPARTMENT OF JUSTICE OFFICE OF COMMUNITY ORIENTED POLICING SERVICES (COPS) HIRING PROGRAM GRANT

WHEREAS, the City of Binghamton Police Bureau is eligible to receive a COPS Hiring Program Grant, in the amount of \$250,000 over a three year period, to fund the hiring of 2 new police officers; and

WHEREAS, the grant was awarded with a local match, with the City contributing \$237,990.00 from budget lines A3120.51000 (WAGES), A9030.58000 (SOCIAL SECURITY), A9015.58000 (RETIREMENT), and A9060 (HEALTH INSURANCE); and

WHEREAS, the grant funds will be administered by Captain David Bidwell, or his designee; and

WHEREAS, the estimated date of completion is September 30, 2028; and the officers employed must be retained a three-year period.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:
