AN ORDINANCE TO AMEND THE 2024 GENERAL FUND BUDGET AND INSURANCE FUND BUDGET TO ADJUST FOR ADDITIONAL LEGAL EXPENSES

WHEREAS, the Comptroller and Treasurer of the City of Binghamton have recommended that the 2024 General Fund budget and Insurance Fund budget be amended for adjusted revenue and expense lines related to increased legal expenses; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on August 28, 2024.

NOW THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2024 General Fund and Insurance Fund budget for adjusted revenue and expense lines related to increased legal expenses as follows:

- (i) \$12,674.23 decrease to expense line A1210.51000 (PRS SVC ASSISTANT TO MAYOR)
- (ii) \$7,796.22 decrease to expense line A1430.51000 (PRS SVC PERSONNEL)
- (iii) \$150,000.00 decrease to expense line A9060.58000C (HEALTH INSURANCE)
- (iv) \$170,470.45 increase to expense line A9901.59000 (INTERFUND TRANSFER)
- (v) \$170,470.45 increase to revenue line M.42801 (INTERFUND TRANSFER)
- (vi) \$10,000.00 decrease to expense line M1910.54450 (VEHICLE REPAIR)
- (vii) \$25,000.00 increase to revenue line M.42401 (INTEREST)
- (viii) \$205,470.45 increase to expense line M1910.54430 (LEGAL SERVICES)

Section 2. That this ordinance shall take effect immediately.
