AN ORDINANCE TO AMEND THE 2024 GENERAL FUND BUDGET TO ADJUST FOR OF TITLE PAY FOR **JUNIOR** ACCOUNTANT

WHEREAS, the Director of Personnel and Safety and the Comptroller of the City of Binghamton find it proper and necessary to amend the 2024 General Fund budget to adjust for out of title pay for Junior Accountant; and

WHEREAS, the Junior Accountant performed out of title duties in the absence of the Treasurer from January 8, 2024 to July 5, 2024; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on September 11, 2024.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and the City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2024 General Fund budget as follows:


