**AN ORDINANCE TO AMEND THE 2024 POLICE
BUDGET TO ADD A PARKING METER
CHECKER**

WHEREAS, the Comptroller and Treasurer of the City of Binghamton find it proper and necessary to amend the 2024 Police Department budget to add a full-time position for a parking meter checker including insurance and retirement benefits in the amount of \$9,314.97; and

WHEREAS, the budget transfer to implement the change for 2024 was approved by the Board of Estimate and Apportionment on September 11, 2024.

NOW THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2024 Police Department budget to add a full-time position for a parking meter checker including insurance and retirement benefits in the amount of \$9,314.97.


