A RESOLUTION AUTHORIZING THE MAYOR TO ACCEPT A GRANT FROM THE DORMITORY AUTHORITY OF THE STATE OF NEW YORK IN THE AMOUNT OF \$231,412.00

WHEREAS, the Mayor of the City of Binghamton wishes to accept a grant from the Dormitory Authority of the State of New York (DASNY) and the NYSWIMS program in the amount of \$231,412.00 to facilitate upgrades to City of Binghamton aquatic facilities; and

WHEREAS, there is a requireed City match of twenty percent (20%) of the grant or \$57,853.00; the Recreation Supervisor will be the grant project manager; and the project is anticipated to begin in the Spring of 2025; and

WHEREAS, the City wishes to accept said grant.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Council of the City of Binghamton does hereby accept a grant from the DASNY NYSWIMS initiative as outlined above; and be it further

RESOLVED that the Mayor, or his designee, is hereby authorized to enter into and execute an agreement, approved as to form and content by the Office of Corporation Counsel, with DASNY to accept such grant and the Comptroller is authorized to amend and/or adjust the budget accordingly.
