AN ORDINANCE TO AMEND THE 2020 BINGHAMTON-JOHNSON CITY JOINT SEWAGE TREATMENT FACILITIES CAPITAL BUDGET FOR EQUIPMENT AND PUMP REPAIRS, AND CHEMICALS

WHEREAS, the City of Binghamton (the "City") is a joint owner of the Binghamton-Johnson City Joint Sewage Treatment Facilities (the "BJCJSTF") with the Village of Johnson City (the "Village"); and

WHEREAS, the BJCJSTF is operated and maintained by the Binghamton-Johnson City Joint Sewage Board (the "JSB") under a series of inter-municipal agreements between the City and the Village; and

WHEREAS, the Council of the City and the Board of Trustees of the Village approve the BJCJSTF budget; and

WHEREAS, the JSB has requested an amendment to the 2020 BJCJSTF budget for equipment and pump repairs, and chemicals.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Council approves and directs the Comptroller/JSB Fiscal Officer to amend and make journal budget entries in the 2020 BJCJSTF budget to increase the appropriations budget for equipment, pump repairs, and chemicals, as follows:

AN ORDINANCE AUTHORIZING THE SALE OF 113 GAYLORD STREET TO JAMES LEWIS AND CAROL LEWIS FOR \$300

WHEREAS, the City of Binghamton is the owner of certain real property located at 113 Gaylord Street, Binghamton, New York, Tax Parcel No. 145.62-2-10 (the "Premises"); and

WHEREAS, the City received an Offer to Purchase the Premises from James Lewis and Carol Lewis (the "Applicant") for \$300 for use of the Premises as green space to their adjacent property at 109 and 111 Gaylord Street; and

WHEREAS, the City has no public use for the Premises; and

WHEREAS, the Assessor of the City of Binghamton has determined the sale price to be fair and equitable; and

WHEREAS, the Board of Estimate and Apportionment approved and recommended sale of the Premises on January 20, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain by at least a three-fourths vote as follows:

- Section 1. That the Mayor of the City of Binghamton is hereby authorized to enter into a contract of sale and to execute all necessary and appropriate documentation, approved as to form and content by the Office of Corporation Counsel, to transfer the Premises to James Lewis and Carol Lewis, by Quitclaim Deed for \$300 to be paid by cash, certified, or local bank check.
- Section 2. This transfer is subject to the following conditions (i) the Premises may only be used as green space to their adjacent property, and (ii) the Premises must be merged with the Applicant's adjacent property located at 109 and 111 Gaylord Street Binghamton, New York, Tax Parcel Nos. 145.62-2-12 and 145.62-2-11, respectively.
 - Section 3. That this Ordinance shall take effect immediately.

The City of Binghamton is transferring 113 Gaylord Street, Binghamton, New York, Tax Parcel No. 145.62-2-10 to James Lewis and Carol Lewis.

Reasons Supporting This Determination:

This is a vacant lot in a residential area. The Purchaser owns the adjoining properties at 109 and 111 Gaylord Street Binghamton, New York. The proposed use is green space for the adjacent property.

The lead agency has determined that the action will not have a significant adverse impact on the environment for the following reasons:

The transfer will preserve green space and provide for future maintenance.
