**AN ORDINANCE TO AMEND THE 2024 PHCD  
BUDGET TO ADJUST FOR RESPONSIBILITY

WHEREAS, the Council of the City of Binghamton and the Comptroller find it necessary and proper to amend the 2024 Planning, Housing, and Community Development (PHCD) budget to provide a responsibility adjustment to the Housing and Community Development Specialist position; and

WHEREAS, the Planning, Housing, and Community Development department requests an inter-departmental transfer of \$2,791.67 for additional responsibilities from October, 21, 2024 to December 27, 2024; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on October 23, 2024.

NOW THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
