A RESOLUTION AUTHORIZING THE MAYOR
TO ACCEPT A GRANT FROM BROOME
COUNTY FOR TOWER VIEWER SIGNAGE IN
THE AMOUNT OF \$2,500

WHEREAS, the Broome County Naturalist Club applied for and received a grant in the amount of \$5,000 from the Klee Foundation to purchase a tower view to be donated to the City of Binghamton with proposed installation on the 434 Greenway; and

WHEREAS, the City of Binghamton applied for and received a grant in the amount of \$2,500 through the Broome County Community Beautification and Environmental Stewardship Grant Program for the purchase and installation of interpretive signage along the 434 Greenway for the newly donated Tower Viewer; and

WHEREAS, there is a \$500 in kind labor match from the City of Binghamton Parks and Recreation Department; and

WHEREAS, a grant line has been established for disbursing funds directly to the Department of Economic Development (A6989.54742); that the Director of Economic Development will be the grant project manager; and that the anticipated date of project completion is Spring 2025.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel, to accept a grant in the amount of \$2,500 from the Broome County Community Beautification and Environmental Stewardship Grant Program.
