AN ORDINANCE TO PROVIDE A ONE-TIME PARKING TICKET AMNESTY FOR 2024

WHEREAS, there are significant uncollected parking fines due to the City of Binghamton anticipated through December 31, 2024; and,

WHEREAS, the City desires to provide for a one-time amnesty program to assist in collection of these fines.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. The Code of the City of Binghamton, Vehicles and Traffic, Article VII, Stopping, Standing and Parking § 400-89. Penalties for violations of article, is hereby amended to add paragraph D as follows:

D. For the period from November 15, 2024, through December 31, 2024, the City of Binghamton offers an amnesty program for parking tickets issued prior to November 25, 2024. The total cost of any ticket, including any penalties and late fees, may be paid at the Original Fine rate (also to include any mandatory New York State surcharges). All payments must be made payable to the City of Binghamton and delivered to the Treasurer's Office, City Hall, 38 Hawley Street, Binghamton, NY 13901 on or before December 31, 2024. This paragraph will automatically expire on January 1, 2025, and will be of no further force or effect.

Section 2. That this ordinance shall take effect immediately.
