# FIRST ORDER OF BUSINESS: APPROVAL OF MINUTES:

### SECOND ORDER OF BUSINESS: BID OPENING:

Bids were opened for 2024 (CHIPS) ADA, Curb and Sidewalk Replacement. Two bids were received, read, and forwarded to Engineering on a motion by Mr. Lake, seconded by Mr. Paludi, and unanimously favored.

Bids were opened for 2024 Curb and Sidewalk Replacement (MISC). Four bids were received, read, and forwarded to Engineering on a motion by Mr. Lake, seconded by Mr. Paludi, and unanimously favored.

Bids were opened for 2024 Catchbasins, Manholes, Streets & Utilities Improvements. Two bids were received, read, and forwarded to Engineering on a motion by Mr. Lake, seconded by Mr. Paludi, and unanimously favored.

Bids were opened for Replacement of High Lift Pump #3. Four bids were received, read, and forwarded to the Water Department on a motion by Mr. Lake, seconded by Mr. Paludi, and unanimously favored.

Bids were opened for Repair of High Lift Pump #1. Three bids were received, read, and forwarded to the Water Department on a motion by Mr. Lake, seconded by Mr. Paludi, and unanimously favored.

#### THIRD ORDER OF BUSINESS: AWARD RECOMMENDATION:

Award recommendation to Bothar Construction LLC for Hiner Road Reconstruction and Culvert Replacement was approved on a motion by Mr. Lake, seconded by Mr. Paludi, and unanimously favored. Cost is \$751,751,85 which was the lowest bid received. Funds are available in H5112.555555.F4397.
