Kenneth Brown, Binghamton resident: Here to speak about O24-93. Expresses concerns about the
potential sale of property to Charles Ackerman, criticizing the lack of changes to the proposal and the
profit margin Ackerman would be making. Suggests Ackerman should contribute profit to the City to
help fund more affordable housing units. Proposes a new revenue source for the City through an annual
licensing fee for rental units

IX. SECOND READING LEGISLATION

CM Dundon states agreement with some of public commenter's points, however, is at the point where he just wants to see something start being built, even if it's not a perfect solution. If this project represents a step forward in getting some housing built, CM Dundon is willing to support it. Also considering other solutions; mentions Binghamton Plaza, depending on what is found in the soil there

CM Hotchkiss states constraints built into legislation on project: City retains right of access, units must be priced at HUD's definition of very-low income for at least 30 years, groundbreaking must occur within 5 years, and City has right to repurchase property. Acknowledges that project isn't perfect, but limited resources are available and all must be used to tackle housing crisis. Adds that multiple local nonprofits involved in homelessness outreach have reached out in support of project. Further adds that parcels have been vacant/unused for decades and City will be making money from real estate sale. Also notes that taxpayer money will be saved, as emergency funding for hotel stays is far more costly than DSS rent payments. Concludes by noting this project carries more restrictions than any other project that has come before the City

CM Porter states knowledge that this project would address a critical need. Hopes to see other local developers follow this lead. Notes to public commenter that CM Middleton is currently discussing rental registry in MPA Committee

CM Cavanaugh notes that this project is particularly of interest because it is a different model from typical projects considered. Typically, projects are either looking for significant upfront costs or seeking large state grants to make them financially viable. Adds that land has been sitting empty for years without desire. Expresses agnosticism around who is doing project, so lost as there is a track record of development

experience. States interest in seeing how project come together; doesn't see a downside, especially as CM Hotchkiss added in various safeguards

CM Hotchkiss notes his own frustration at how few projects actually break ground following announcements; points to 191 Front St project (set for public hearing today) first being announced in 2019. Reiterates openness to exploring multiple solutions to crisis. Can't justify eliminating opportunities for residents to have a roof over their heads

CM Mativetsky agrees with colleagues' sentiments. Acknowledges campaign contributions from Ackerman, but points out that project moved through regular channels and price of sale was set by City Assessor, not City Council. Adds that City benefits from not having empty parcels that need maintenance and hold liability. Also states that other potential components will have to meet further approval: Planning Commission, PILOT, etc.

CM Cavanaugh states willingness to support this project regardless of \$50 donation
