<b>DESCRIPTION FROM AGENDA:</b> The applicant, James Marotta, would like to install a sign on the front window of the building.		
Certificate of Appropriateness		
DISCUSSION POINTS & THOSE SPEAKING:		

• Commissioner asks if it conforms to our guidelines for space and coverage.

- Staff replies that the sign coverage is 43% of the window and the historic district in Binghamton only allows for 33% or 1/3.
- Applicant states that the window is not 36 inches but rather 30 inches in height.
- Commissioner asks if that is 33% of the window.
- Staff replies that it is still over 33% of the window and if the sign were to only take up 1/3 of the window, the sign can only be 27 inches high.
- Commissioner states that the sign seems crowded and the applicant may want to simplify the sign by putting the information on two of the windows instead of one.
- Commissioner states that the applicant was at the last meeting and had privacy concerns over the space behind the glass on the first floor.
- Applicant states that the perforated vinyl window sign extends along the front and matches the colors on the next building over.
- Applicant also states that for safety concerns pedestrians should not be able to look into the building on the first floor.
- Commissioner states that the vinyl applications have been problematic in the past, but due to the privacy
  concerns, it is more appropriate in this context. However, the percentage of window coverage should be 33%
  of the window.

- Commissioner states that some of the old garages built during the 1920's and 30's had not only water faucets on the garages, but also gas hookups. Caution should be exorcised during demolition.
- Applicant states that there is approximately a foot of dirt pushed up against the south side of the garage leading to insect damage and water damage.

# **DISCUSSION POINTS & THOSE SPEAKING:**

- Applicant states that the structure located at that address is not the primary structure, but rather an accessory structure to a mansion located on Main Street.
- Commissioner points out that the brackets on the third floor of the original razed structure are actually over 200 individually carved faces around the mansion.
- Commissioner states that the building has gone through several phases of renovation, sustained at least one fire, and is likely at the end of it's lifespan.
- Speaker is a local resident, Giovanni Scaringi, 189 Matthews Street.
- Speaker states that the building has had not one, but two fires, both drug related. Speaker also states that the building has not been occupied in over 8 years and is not worth renovating.

# **DISCUSSION POINTS & THOSE SPEAKING:**

- Commissioner states that he has a problem with this building coming down related to the historical significance of the structure.
- Commissioner states that he sees this building as a salvageable property for the city.
- Applicant (Staff) states that the building will be visited by a structural engineer tomorrow and an assessment will be given based on the economic viability and structural integrity of the building.
- Applicant states that although the previous owner took all of the interior walls and materials out of the house, the framing seemed salvageable and the structure may be useful.
- Commissioner states that from a developer's standpoint, that is a positive step being that all the interior of the building would have to be demolished anyway to make the interior up to current code.
- Applicant states that it was noted that a load bearing wall was removed, but the wall was in the attic supporting the roof and could easily be replaced without changing the structural integrity of the building.
- Commissioner states that the building used to have a tower in the front that was removed a long time ago.
- Commissioner motions to table the decision until the engineering report is issued.
