The meeting of the Board of Contract and Supply was called to order at 11:05 a.m.

**FIRST ORDER OF BUSINESS: APPROVAL OF MINUTES:**

An approval of the minutes from the May 12, 2021 meeting and the May 13, 2021 special meeting was approved on a motion by Mr. Paddock and seconded by Mr. Lake and unanimously favored.

**SECOND ORDER OF BUSINESS: AWARD RECOMMENDATION:**

An award recommendation for the bid for 2021 Robinson Street Reconstruction was awarded to the lowest bidder, G. DeVincentis & Sons Construction at a bid price of \$1,142,000.00 on a motion by Mr. Lake and seconded by Mr. Paddock and unanimously favored. **THIRD ORDER OF BUSINESS: CONTRACT APPROVAL:**

A one year contract with Foam-It Insulation for the concrete sidewalk leveling in the amount of not to exceed \$25,000 the lowest of two written quotes from the provider of this type service in the area was approved on a motion by Mr. Lake and seconded by Mr. Paddock and unanimously favored. **FOURTH ORDER OF BUSINESS: PERMISSION TO DISPOSE:**

An approval for the disposal of (3) vehicle that was abandoned on City property by a licensed New York State dismantler as required by Section 1224 5b of NY State traffic law was approved on a motion by Mr. Paddock and seconded by Mr. Shager and unanimously favored.
