AN ORDINANCE TO AMEND THE 2020 VITAL STATISTICS BUDGET TO RECONCILE PERSONAL SERVICES

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Vital Statistics budget for an end of the year reconciliation for personal services; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 6, 2021.
