ORDINANCE

AN ORDINANCE TO AMEND THE 2020 FIRE DEPARTMENT BUDGET FOR OVERTIME

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Fire Department Budget for overtime; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on January 6, 2021.
