A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (MOU) FOR THE SUBMITTAL OF A REGIONAL ASSISTANCE TO FIREFIGHTERS GRANT FOR EXTRICATION TOOLS FOR THE CITY OF BINGHAMTON FIRE BUREAU

WHEREAS, the Chief of the City of Binghamton Fire Bureau, has requested to enter into a Memorandum of Understanding for the submittal of a Regional Assistance to Firefighters grant for extrication tools for the City of Binghamton Fire Bureau together with the Town of Kirkwood, Town of Conklin, Town of Binghamton, and Five Mile Point Fire Departments; and

WHEREAS, the City of Binghamton Fire Bureau tools will be at a cost of \$76,300 with a ten (10%) percent cash match for a cost of \$7,630.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, Chief of the City of Binghamton Fire Bureau, or their designee, is hereby authorized to enter to enter into a Memorandum of Understanding, approved as to form and content by the Office of Corporation Counsel, with the Town of Kirkwood, Town of Conklin, Town of Binghamton, and Five Mile Point Fire Departments for the submittal of a Regional Assistance to Firefighters grant for extrication tools for the Binghamton Fire Department at a cost not to exceed \$76,300 with a ten percent cash match of \$7,630; and funds shall be deducted from budget line A3410.52600 (Equipment) for this purpose.
