AN ORDINANCE APPROVING AN ALLOCATION OF FUNDS FROM THE FLOOD MITIGATION RESERVE FUND FOR RESTORATION OF THE CHENANGO RIVER TRAIL LEVEE PROJECT

WHEREAS, the Council of the City of Binghamton adopted Permanent Ordinance 018-36, dated March 21, 2018, entitled "An Ordinance to Establish a Flood Mitigation Reserve Fund in the Amount of \$800,000"; and

WHEREAS, the Mayor has requested an allocation of \$106,893 from the Flood Mitigation Reserve Fund for a specific flood mitigation project, *i.e.*, restoration of the Chenango River Trail Levee; and

WHEREAS, pursuant to Permanent Ordinance 018-36, the Corporation Counsel and Comptroller of the City of Binghamton have verified that this allocaiton is a purpose authorized by the Flood Mitigation Reserve Fund and General Municipal Law § 6-c, or any other law; and

WHEREAS, the Comptroller of the City of Binghamton wishes to amend the 2021 Capital budget to create a new expense budget line for the Chenango River Trail Levee project; and

WHEREAS, City Council must approve any allocation of funds from the Flood Mitigation Reserve Fund.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

- Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Capital budget to create new budget line H7110.xxxxxx (Restore Chenango River Trail Project) for design and related costs for restoration of the Chenango River Trail Levee.
- Section 2. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2021 Capital budget to allocate funds from the Flood Mitigation Reserve Fund for the Chenango River Trail Levee project as follows:
 - (i) \$106,893 decrease to revenue budget line A.878A (Flood Mitigation Reserve)

- (ii) \$106,893 increase to expense budget line A9950.59000 (Transfer to Capital)
- (iii) \$106,893 increase to revenue budget line H.45031 (Interfund Transfer)
- (iv) \$106,893 increase to expense budget line H7110.xxxxxx (Restore Chenango River Trail project)
- Section 3. That this Ordinance shall take effect immediately.

WHEREAS, the Council of the City of Binghamton passed Permanent Resolution 20-53, dated June 17, 2020, authorizing the Mayor to enter into an agreement with YWCA for the use of CARES ACT COVID-19 relief funds for street outreach; and

WHEREAS, the Council of the City of Binghamton passed Permanent Resolution 20-48, dated June 17, 2020, authorizing the Mayor to enter into an agreement with the Family Enrichment Network for the use of CARES ACT COVID-19 relief funds for homeless prevention services; and

WHEREAS, the Council of the City of Binghamton passed Permanent Resolution 21-13, dated February 17, 2021, authorizing the Mayor to amend the Family Enrichment Network agreement; and

WHEREAS, the City wishes to amend the Family Enrichment Network agreement and budget to change the scope of work from homeless prevention to rapid rehousing, including an outreach worker, and to reduce the amount of funding by \$61,418; and to amend the YWCA agreement and budget to increase funding in the amount of \$61,418 for an outreach worker, including related travel and phone expenses.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

Resolve that the Mayor, or his designee, is hereby authorized to amend the Family Enrichment Network agreement and budget to change the scope of work from homeless prevention to rapid rehousing, including an outreach worker, and to reduce the amount of funding by \$61,418; and to amend the YWCA agreement and budget to increase funding in the amount of \$61,418 for an outreach worker, and related travel and phone expenses.

WHEREAS, the Council of the City of Binghamton adopted Permanent Resolution 19-86, dated October 23, 2019, with Tetra Tech for the Binghamton levee study and improvements project at a cost not to exceed \$183,529; and

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN EQUIPMENT RENTAL LEASE AGREEMENT WITH VGM FINANCIAL SERVICES FOR GOLF CARTS AND A CLUB CAR CARRYALL VEHICLE

WHEREAS, the City of Binghamton wishes to enter into a lease agreement with VGM Financial Services for golf carts and a club car carryall vehicle; and

WHEREAS, the term of the lease is for five (5) years effective from October 1, 2021 through November 30, 2026; and

WHEREAS, the amount the lease is not to exceed \$508,370.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session does hereby:

RESOLVE, that the Mayor, or his designee, is hereby authorized to enter into a lease agreement with VGM Financial Services for golf carts and a club car carryall vehicle for a five (5) years effective from October 1, 2021 through November 30, 2026 in a total amount to not to exceed \$508,370, and that in 2021, \$14,187.85 shall be deducted from budget line CR9785.56000 (Other Debt Principal) and \$1,468.86 from budget line CR9785.57000 (Other Debt Interest) for this purpose.
