WHEREAS, pursuant to the Code of the City of Binghamton § 229-2, *Fireworks authorized*, § 235-18, *Fireworks displays*, and New York State Penal Law § 405, it is necessary for the Council of the City of Binghamton to authorize any requested fireworks displays; and

WHEREAS, on May 5, 2021, the Council of the City of Binghamton adopted Permanent Resolution 21-34 granting permission to the Binghamton Rumble Ponies to conduct fireworks displays during the 2021 season; and

WHEREAS, the Binghamton Rumble Ponies have requested permission to conduct an additional fireworks display at NYSEG Stadium on May 28, 2021; and

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Binghamton Rumble Ponies are hereby granted permission for an additional fireworks display to be held on May 28, 2021; and be it further

RESOLVED that all fireworks displays are subject to all terms and conditions previously approved in Permanent Resolution 21-34.
