WHEREAS, the City of Binghamton contracted with Streeter Associates for the Binghamton-Johnson City Joint Sewage Treatment Facilities; and

WHEREAS, the City Engineer recommends the Mayor enter into an agreement with Streeter Associates Company for Change Order No. 16 at a cost of \$320,000, which exceeds 25% of the original contract price after approval of prior change orders; and
