AN ORDINANCE TO AMEND THE 2021 PARKS BUDGET FOR PLAYGROUND EQUIPMENT REFURBISHMENT

WHEREAS, the Commissioner of Parks and Recreation and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 Parks budget for playground equipment refurbishment; and

WHEREAS, the cost is not to exceed \$22,000; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on April 21, 2021.
