A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH CLARK PATTERSON LEE FOR ARCHITECTURAL AND ENGINEERING DESIGN SERVICES FOR THE NEW YOUTH RECREATION CENTER AT COLUMBUS PARK

WHEREAS, the Mayor of the City of Binghamton wishes to enter into an agreement with Clark Patterson Lee for architectural and engineering design services for the new Youth Recreation Center at Columbus Park; and

WHEREAS, the estimated cost for such services is not to exceed \$548,900.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with Clark Patterson Lee for architectural and engineering design services for the new Youth Recreation Center at Columbus Park, at a cost not to exceed \$548,900; and that \$500,000 shall be deducted from budget line CD7310.533536.CDY46 (Youth Capital Program) and \$48,900 from budget line H7110.XXXXXX (Youth Recreation Center) for this purpose.
