A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE CONTRACT WITH THE YWCA FOR THE USE OF FY 45 ESG FUNDING FOR EMERGENCY SHELTER PROGRAMMING

WHEREAS, pursuant to Permanent Resolution 19-117, dated December 18, 2019, the City of Binghamton entered into a contract with the YWCA for the use of FY 45 ESG funding for Emergency Shelter Programming; and

WHEREAS, the Manager, HUD Administration and Housing, recommends amending the budget for the FY 45 contract with the YWCA to increase the Shelter Coordinator line by \$800.94 and the Residential Director/Social worker line by \$3,466.19, and decreasing the Weekend Resident Assistance line by \$4,267.13.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to amend the contract, approved as to form and content by the Office of Corporation Counsel, with the YWCA to increase the Shelter Coordinator line by \$800.94 and the Residential Director/Social worker line by \$3,466.19, and to decrease the Weekend Resident Assistance line by \$4,267.13.
