## **ORDINANCE**

AN ORDINANCE TO AMEND THE 2021 FIRE BUDGET ADDITIONAL TO ADD **ONE** FIREFIGHTER UNTIL AUGUST 1, 2021

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2021 Fire Budget to add one additional firefighter until August 1, 2021; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on March 24, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in special session, does hereby ordain as follows:

That the Comptroller and City Treasurer of the City of Binghamton are Section 1. hereby authorized and directed to amend the 2021 Fire Budget to add one additional firefighter until Augiust 1, 2021 as follows.
