WHEREAS, the City of Binghamton Fire Department is seeking approval to apply for the FEMA Staffing for Adequate Fire and Emergency Response (SAFER) Grant; and

WHEREAS, the grant would cover four (4) firefighters for a period of three (3) years; and

WHEREAS, the grant will cover 100 percent of the salary and benefits of the firefighters for three (3) years with no cost sharing requirements for the City of Binghamton.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to apply for the FEMA Staffing for Adequate Fire and Emergency Response (SAFER) Grant; and be it further

RESOLVED that if the application for the SAFER Grant is approved, it will be submitted to City Council to approve acceptance of the Grant.
