A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE CONTRACT WITH SALVATION TEMPLE CHURCH FOR THE USE OF FY45 CDBG FUNDS

WHEREAS, pursuant to Permanent Resolution 20-76 dated August 19, 2020, the City of Binghamton entered into a contract with Salvation Temple Church for use of FY 45 CDBG funds in an amount not to exceed \$10,500 for capital upgrades to support local community meal programs; and

WHEREAS, the HUD Administration and Housing Manager recommends a change in scope of the contract to include potential plumbing upgrades and the purchase and installation of a gas range and dishwasher.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an amended contract, approved as to form and content by the Office of Corporation Counsel, with Salvation Temple Church to change the scope of the contract to include potential plumbing upgrades and the purchase and installation of a gas range and dishwasher; and that this amendment does not change the total amount of the contract not to exceed \$10,500.
