**AN ORDINANCE TO AMEND THE 2020 FIRE  
DEPARTMENT BUDGET FOR OVERTIME**

WHEREAS, the Fire Chief and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Fire Department Budget to transfer funds from Police and Fire Retirement to Fire Overtime for overtime; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on December 23, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Fire Department Budget to transfer funds from Police and Fire Retirement to Fire Overtime for overtime as follows:

Transfer From (Decrease):

\$82,481 A9015.58000 (Police and Fire Retirement)

Transfer To (Increase):

\$82,481 A3410.51900 (Fire Overtime)

Section 2. That this ordinance shall take effect immediately.
