**AN ORDINANCE TO AMEND THE 2020 STATE
RETIREMENT BUDGET FOR POLICE, FIRE,
AND NEW YORK STATE EMPLOYEE
RETIREMENT**

WHEREAS, the Comptroller of the City of Binghamton finds it proper and necessary to amend the 2020 State Retirement budget to transfer funds from Police and Fire Retirement to State Employee Retirement; and

WHEREAS, the budget transfer was approved by the Board of Estimate and Apportionment on December 23, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 State Retirement budget to transfer funds from to transfer funds from Police and Fire Retirement to State Retirement as follows:

Transfer From (Decrease):


\$58,531.21 A9015.58000 (Police and Fire Retirement)

Transfer To (Increase):

\$58,531.21 A9010.58000A (State Employee Retirement)

Section 2. That this ordinance shall take effect immediately.
