## RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR TO APPROVE A LEASE BETWEEN BELL ATLANTIC MOBILE SYSTEMS LLC D/B/A VERIZON WIRELESS AND THE RUMBLE PONIES FOR LEASE OF A PORTION OF 211 HENRY STREET FOR INSTALLATION OF A CELLULAR ANTENA

WHEREAS, the City of Binghamton is the owner of 211 Henry Street, Parcel ID 160.26-3-6 (the "Stadium"); and

WHEREAS, pursuant to Permenant Resolution R20-89, dated September 9, 2020, City Council authorized the Mayor to enter into a lease with BELL ATLANTIC MOBILE SYSTEMS LLC d/b/a Verizon Wireless ("Verizon"), for a portion of the Stadium for installation of a cellular antenna; and

WHEREAS, the Stadium is sublet to the Binghamton Mets Baseball Club, Inc. a/k/a the Binghamton Rumble Ponies (the "Rumble Ponies"), a New York Mets AA Minor League Baseball team; and

WHEREAS, when the lease was approved by Permenant Resolution R20-89, Major League Baseball had identified the Rumble Ponies as a team to be eliminated from Minor League Baseball; and

WHEREAS, subsequent to the date of Permenant Resolution R20-89, Major League Baseball approved continuation of the Rumble Ponies at the Stadium; and

WHEREAS, in light of this change, the City has agreed that the Rumble Ponies may receive the rent from Verizon, provided that the Rumble Ponies continue to play baseball at the Stadium as a New York Mets AA Minor League Baseball team, otherwise the rent will be payable to the City; and

WHEREAS the City, as the owner of the Stadium, wishes to approve the lease between Verizon and the Rumble Ponies.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:
