AN ORDINANCE TO AMEND THE CODE OF THE CITY OF BINGHAMTON, CHAPTER 5 REGARDING RECORDS RETENTION

WHEREAS, the Code of the City of Binghamton, Chapter 5, Administration of Government, §5-23 Adoption of Records Retention and Disposition Schedule, needs to be updated to the current Retention and Disposition Schedule for New York Local Government records (LGS-1).

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Code of the City of Binghamton, Chapter 5, *Administration of Government*, §5-23 *Adoption of Records Retention and Disposition Schedule*, paragraph "A" is hereby repealed and replaced in its entirety as follows:

§ 5-23. Adoption of Records Retention and Disposition Schedule.

A. The City of Binghamton hereby adopts the Records Retention and Disposition Schedule LGS-1, published by the New York State Archive and Records Administration, containing record retention times for the various records held within City Hall, as may be amended from time to time.

Section 2. That this ordinance shall take effect immediately.
