## **ORDINANCE**

AN ORDINANCE TO AMEND FISCAL YEAR 46 HUD ANNUAL ACTION PLAN

WHEREAS, pursuant to Permenant Ordinance 20-61, dated July 8, 2020, City Council adopted the Fiscal Year 46 HUD Annual Action Plan; and

WHEREAS, pursuant to a "Corrected Notice" from HUD dated October 20, 2020, certain budget lines need to be amended in order to correct an error in the formula calculations for certain programs.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

Section 1. That the Comproller and City Treasuer of the City of Binghamton are herby authorized and directed to amend the Fiscal Year 46 HUD Annual Action Plan, as follows:

- (i) Reduce budget line CD.44910.CDY46 (Fed Aid-Community Dev Act) from \$1,938,269 to \$1,938,040;
- Reduce budget line CD8668.533509.CDY46 (Homeownership/Rehab) from (ii) \$190,000 to \$189,772;
- Reduce budget line CE.44989.CEY46 (Fed Adi-Other Home & Comm Svcs) from (iii) \$533,491 to \$533,407; and
- Reduce budget line CE8668.533800.CEY46 (Rehab) from \$267,241.57 to (iv) \$267,157.57.

Section 2. That this Ordinance shall take effect immediately.
