**AN ORDINANCE TO AMEND THE 2020
MAYOR'S BUDGET FOR ADDITIONAL
CORONA VIRUS EXPENSES**

WHEREAS, the Mayor and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Mayor's budget to create and fund new budget expense line A1210.525900 (CoronaVirus Expense) to capture additional expenses to control the spread of the disease; and

WHEREAS, the budget amendment and transfers were approved by the Board of Estimate and Apportionment on December 9, 2020.

NOW THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Mayor's Office to create new budget expense line A1210.525900 (CoronaVirus Expense) to capture additional expenses to control the spread of the disease; and to fund same as follows:

Transfer From (Decrease):

\$18,861 A1990.55000 (Contingency)
1,139 A9015.58000 (Police and Fire Retirement)

\$20,000


Transfer To (Increase):

\$20,000 A1210.525900 (CoronaVirus Ex.)

\$20,000

Section 2. That this ordinance shall take effect immediately.
