## **ORDINANCE**

entitled

AN ORDINANCE TO AMEND THE 2020 FINANCE BUDGE TO ADD A FINANCE PAYROLL SPECIALIST

WHEREAS, the Director of Personnel & Employee Safety and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Finance budget to (i) defund the position of "Payroll Supervisor" at an annual salary of \$46,710, and (ii) add a "Finance Payroll Specialist" at an annual salary of \$41,500; and to fund same from December 12 through December 31, 2020; and

WHEREAS, such budget amendments and transfers were approved by the Board of Estimate and Apportionment on December 9, 2020; and insofar as the "Finance Payroll Specialist" is an existing job title in the City, no Civil Service Commission approval is necessary.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Finance budget to (i) defund the position of "Payroll Supervisor" at an annual salary of \$46,710, and (ii) add a "Finance Payroll Specialist" at an annual salary of \$41,500; and to fund the "Finance Payroll Specialist" from December 12 through December 31, 2020, with the excess balance transferred to the contingency account, as follows:
