A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE BINGHAMTON LOCAL **DEVELOPMENT** CORPORATION FOR USE OF FY 46 CDBG FUNDING IN AN AMOUNT NOT TO EXCEED \$145,000

WHEREAS, the City of Binghamton wishes to enter into an agreement with the Binghamton Local Development Corporation for use of Fiscal Year 46 Community Development Block Grant funding in an amount not to exceed \$145,000.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the Binghamton Local Development Corporation for use of Fiscal Year 46 Community Development Block Grant funds in an amount not to exceed \$145,000; and that funds shall be deducted from budget line CD6889.54000.CDY46 (Contractual) for this purpose.
