
A RESOLUTION AUTHORIZING THE MAYOR
TO ENTER INTO AN AGREEMENT WITH THE

RESOLVE that the Mayor of the City of Binghamton, or his designee, is hereby authorized to enter into an agreement, approved as to form and content by the Office of Corporation Counsel, with the United Way of Broome County for marketing promotion of the 2-1-1 COVID assistance program at a cost not to exceed \$16,000; and that funds shall be deducted from budget line CD8760.535001.CVY45 (EDW-ADMIN) for this purpose.
