RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR TO AMEND THE CONTRACT WITH CHOW FOR USE OF FY45 CDBG FUNDING FOR DEVELOPMENT OF A GROCERY STORE

WHEREAS, pursuant to Permanent Resolution 20-13, dated March 4, 2020, the City of Binghamton entered into a contract with Broome County Council Of Churches Inc. ("CHOW") for use of FY 45 CDBG funds in an amount not to exceed \$150,000 for development of a grocery store; and

WHEREAS, the Manager, HUD Administration and Housing, recommends a change in scope of the contract from grocery store buildout to grocery store equipment.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to amend the contract, approved as to form and content by the Office of Corporation Counsel, with CHOW to change the scope of the contract from grocery store buildout to grocery store equipment; and that this amendment does not change the total amount not to exceed \$150,000.
