## RESOLUTION

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO SUPPLEMENTAL NO.1 AGREEMENT WITH KEYSTONE ASSOCIATES, ARCHITECTS, ENGINEERS, AND SURVEYORS LLC FOR GEOTECHNICAL SERVICES FOR THE NEW FIRE STATION

WHEREAS, pursuant to Permanent Resolution 20-72, dated August 5, 2020, the City entered into an agreement with Keystone Associates, Architects, Engineers, and Surveyors LLC for design servies for the new fire station; and

WHEREAS, the City Engineer recommends the City enter into Supplemental No.1 Agreement with Keystone Associates, Architects, Engineers, and Surveyors LLC for geotechnical services, at a cost not to exceed \$14,300.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into Supplemental No.1 Agreement approved as to form and content by the Office of Corporation Counsel, with Keystone Associates, Architects, Engineers, and Surveyors LLC for geotechnical services at a cost not to exceed \$14,300; and funds shall be deducted from budget line H3140.525326.72720 (New Fire Station) for this purpose.
