**AN ORDINANCE TO AMEND THE 2020
BUILDING EQUIPMENT AND IMPROVEMENT
MAINTENANCE BUDGET FOR LIGHTING
REPAIRS AND CLEANING SERVICES**

WHEREAS, the Commissioner of Public Works and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Building Equipment and Improvement Maintenance budgets for lighting repairs and cleaning services at the DPW Garage; and

WHEREAS, such budget amendments were approved by the Board of Estimate and Apportionment on November 4, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:
