**AN ORDINANCE TO AMEND THE 2020 RISK
MANAGEMENT BUDGET FOR LEGAL
SERVICES**

WHEREAS, the Corporation Counsel and Comptroller of the City of Binghamton find it proper and necessary to amend the 2020 Risk Management budget to provide for additional legal services; and

WHEREAS, some funds in this transfer were encumbered from the 2019 Risk Management budget; and

WHEREAS, such budget amendment was approved by the Board of Estimate and Apportionment on November 4, 2020.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby ordain as follows:

Section 1. That the Comptroller and City Treasurer of the City of Binghamton are hereby authorized and directed to amend the 2020 Risk Management budget for additional legal services as follows:

Transfer From (Decrease):
\$175,000 M1910.54900 (Prov for Incurred Loss)

Transfer To (Increase):
\$175,000 M1910.54430 (Legal Services)
