A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH EXCELLUS BLUE CROSS FOR DENTAL AND VISION ADMINISTRATION

WHEREAS, the City is self-insured for certain employee health plans; and

WHEREAS, Excellus Blue Cross/Blue Shield provides the policies, parameters, and administration for the dental and vision plans; and

WHEREAS, the City wishes to contract with Excellus Blue Cross/Blue Shield for such services for January 1, 2021, through December 31, 2021; and

WHEREAS, funding for the estimated costs for such services are included in the 2021 budget in various budget lines and that the final cost will be based on actual claims and administration.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE, that the Mayor, or his designee, is hereby authorized to execute any and all necessary documentation, approved as to form and content by the Office of Corporation Counsel, with Excellus Blue Cross/Blue Shield for dental and vision administration for 2021 and that funds in the estimated amount of \$6,800,000 are available from various budget lines for this purpose.
