A RESOLUTION AUTHORIZING THE MAYOR ENTER INTO AN AGREEMENT WITH THE DORMITORY AUTHORITY OF THE STATE OF NEW YORK (DASNY) FOR A \$250,000 GRANT **FOR** VARIOUS **IMPROVEMENTS AND** MAINTENANCE PROJECTS AT ROSS PARK

WHEREAS, the City of Binghamton Parks and Recreation Department and the Planning, Housing and Community Development Department are seeking approval to accept a \$250,000 grant from the Dormitory Authority of the State of New York ("DASNY") for various parks improvements; and

WHEREAS, the total estimated project cost is \$250,000, of which \$250,000 will be provided by the DASNY grant; and

WHEREAS, the Parks Commissioner and Director of Planning, Housing and Community Development shall be the grant administrators, the local match is "in kind" services, and the estimated date of project completion is July 31, 2021.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to execute any and all documents, approved as to form and content by the Office of Corporation Counsel to accept a \$250,000 grant from DASNY for various parks improvements, and be it further

RESOLVED that Parks Commissioner and Director of Planning, Housing and Community Development shall be the grant administrators, the local match is "in kind" services, and the estimated date of project completion is July 31, 2021.
