WHEREAS, the City of Binghamton and the Town of Union wish to enter into an Intermunicipal Agreement for a coordinated entry system.

NOW, THEREFORE, the Council of the City of Binghamton, duly convened in regular session, does hereby:

RESOLVE that the Mayor, or his designee, is hereby authorized to enter into an Intermunicipal Agreement, approved as to form and content by the Office of Corporation Counsel, with the Town of Union for a coordinated entry system for a shared caseworker for CDBG-CV emergency rent/utility and mortgage/utility programs.
